Dear Fellow Lighthouse Enthusiasts,

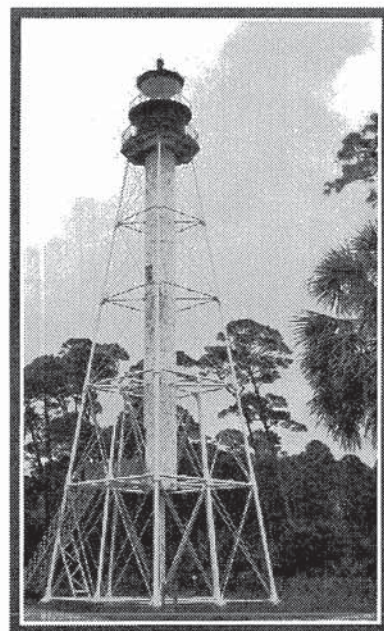

FLA-Gene Oakes Memorial License Plate Fund

In a survey form many members filled out, the topic garnering the most mentions in answering the question of "one thing you'd like to see FLA do" was "get the license plate!"

For good reason! First mentioned back during Tom Taylor's presidency, the license plate project has had more ups and downs than a Disney World ride.

When Gene Oakes served as president, he tried to kick-start the campaign again. He noted that the license plate fund would be the single annual appeal to focus attention on a gift that keeps on giving. A license plate provides a sustainable source of funds to help all Florida lighthouses, as an annual appeal was intended. He vigorously promoted the idea. The Tampa Bay Harbour Lights Collectors Club was first in with \$1,000 as Wayne Hawes offered a challenge on behalf of the club, followed by a number of individuals and associations: Lighthouse and Historic Building Society, Ponce de Leon Inlet Lighthouse Preservation Association, St. Augustine Lighthouse and Museum, Mary Dorsey, Glenn Swigart, Stan and Mary Farnham, and Harry and Jean Pettit. Although a good start, Gene passed away January 20, 2006 before he could complete the license plate mission.

At the Board of Commissioners meeting April 21, we renamed the license plate fund the "Gene Oakes Memorial License Plate Fund" and appointed Beverly Oakes chairperson of the committee. Appropriately, she would like to carry out Gene's dream of having a Florida specialty license plate. The license plate will generate many times its cost in restoration funds. Clearly the license plate also "advertises" *Save Our Lights*.



At the Board meeting, I pointed out we need to sharply focus on this with a relentless effort (until we reach the needed funds), announce a specific dollar goal and display a "thermometer chart" to show progress. An 18-page report by the Department of Motor Vehicles, RS-20, explains the procedure. The application fee is \$60,000. A survey is required, the license plate artwork of course, a marketing strategy and legislation. All this adds to the total cost. More than 14.9 million vehicles are registered in Florida. One index shows 83 specialty plates, but perhaps there are more now.

At the General Membership meeting at Tierra Verde the next day, April 22, we had a ceremony to explain the newly named fund and the new chairperson. I noted we were mailing certificates to Mary Dorsey and Glenn Swigart, each of whom gave \$1,000 last year but had not received their certificates.

Beverly Oakes said: "Gene told me that if he asked members to give \$1,000 then he should do so. He passed away before he could do this, so here's a \$1,000 check in his honor." Mary and I gave another \$1,000 after having donated \$1,000 last year. Gail Stenac presented a check for the fund for \$1988 from the proceeds of the Bahamas cruise, an idea Gene had. Add to that some additional money from the auction, funds donated in Gene's memory (\$650) and we boosted the fund more than \$4,800 to around \$20,000.

Ed Butler asked: "If we continue at the past rate, it will take a long while to get there. Can we get corporate funds?" "Yes, we do need to examine going after other benefactors, bequests, endowments, corporate sponsorships and possible ads in FLASH," I replied.

As I said at the meeting: "with your gift to the fund, or volunteering your time, you plant the seeds for future success of FLA in carrying out its mission." *Save Our Lights*.

Cape St. George Recovery Efforts

The Cape St. George Lighthouse may have fallen into the Gulf of Mexico but it is not "down and out". Actually, just the opposite has happened. The St. George Lighthouse Association is determined to salvage the pieces of the Light, move them off Little St. George Island for safe storage, and eventually rebuild the Light on safer ground. More than 150 tons of bricks have been transported from Little St. George Island to a storage site in Eastpoint. The bricks are accumulating at the storage site and making a formidable pile.

For those planning on attending the July meeting at the Cape San Blas Lighthouse, the St. George Lighthouse Association has extended an invitation to visit the site and see the salvage in progress. By the time of the meeting, the group hopes to have some type of billboard identifying the site and their work.

For those traveling West, upon entering Eastpoint on US98, the most notable street signs are the ones toward St. George Island and the State Park. Just one street West of SR300 on US98 is Begonia Street. Turn left onto Begonia, and the storage site is at the base of the Oyster Radio tower. Use the tower as a landmark as it can be seen for miles in most directions. The site has a chain link fence for security and adequate parking for anyone who wants to view the pieces.

Recognize: Stan recognized 10 members attending their first FLA meeting, including Ed Gunn, the Operations Director from Ponce Inlet and Paul Wenglowsky from St. Augustine; the new FLA Executive Vice President. He recognized Suzanne Alston of Georgia as an out of state attendee; and who traveled the farthest.

Volunteers: Stan recognized Eric Martin and Judie Trotter for their continuous volunteer efforts at the Central Florida Fair.

License Plate Fund: Beverly Oakes has agreed to Chair the "Gene Oakes Memorial License Plate Fund." Donations were presented and include: Stan & Mary Farnham donated \$1000.00. Beverly Oakes presented a check for \$1000.00 in memory of Gene Oakes; Gayle Stemac presented a check for \$1988.60; proceeds from the donations on the January "Bahamas Cruise." Certificates are being mailed to earlier \$1,000 donors: Mary Dorsey and Glenn Swigart.

Survey Forms: Stan encouraged members to fill survey forms out: 47 were turned in.

Guest Speakers: Stan introduced the two guest speakers: Senior Chief Rod Storle and Captain Peter Clark, Executive Director of Tampa Bay Watch.

- **Senior Chief Rod Storle** recognized one of the USCG members that had recently achieved over 300 hours of volunteer service with the Florida Parks Service and the Anclote Key Lighthouse. Although he was not present, he was thanked with a warm round of applause by the members. Senior Chief Storle announced he would be relocating to the Chesapeake area.

- **Peter Clark**, Executive Director of the Tampa Bay Watch, an environmental non profit organization started in 1993, presented an informative slide show and answered questions about the organization and the Tierra Verde Lighthouse. Stan Farnham and Gayle Stemac presented appreciation certificates to the speakers following their excellent presentations; and a going away gift to Chief Storle.

Break: Members took a 15-minute break.

Officers Reports:

Secretary: Christi Sessions, with this being her first meeting as secretary, no report was given. Previous minutes are on the website and in FLASH.

Treasurer: George Diller was not present, but provided a written report. Key numbers: License

Plate Fund Balance: \$15,998.00. Total Assets: \$73,792.21

Ex. VP: Paul Wanglowsky reported that St. Augustine Lighthouse would no longer be able to hold the FLA Archives; a new location is needed by June.

VP-Membership: Dede Smith reported 17 new memberships since our last meeting and two new members joined the day of the meeting.

VP-Fund Raising: Charley Knox announced that the 2nd ornament in the lighthouse series would be Pensacola. It should be available at the next meeting. He is working on a screen-printed pocket T-shirt. The Board approved a brochure that will be featured in the Visitor Center on I-75 and I-95, and approved FLA paying the fees to become a member of VISIT FLORIDA. The brochure includes a story about how the FLA started, how to join the FLA and FLA merchandise for sale. Merchandise will soon be available on the web-site. Charley asked members to take some of the ornaments on consignment to sell to family and friends. Stan added that the funds approved at the board meeting to fund brochures and products are an investment in the future of FLA.

VP-Meeting and Events: Gayle Stemas reported that we would board the boats to Egmont Key starting at 3:00 p.m. Gayle reported that at the next meeting, July 15th, will be at Cape San Blas, and we would be able to climb the lighthouse. Danny Raffield agreed to host 4 members to tour his home, The St. Joseph Point Light. There will be a raffle at the meeting to choose the four members. The proceeds of the raffle will go to the Gene Oakes Memorial License Plate Fund. Bob and Sandra Shanklin will be guest speakers at the meeting. Our 10th Anniversary meeting in October will be at Sanibel. The meeting in January will be an afternoon meeting and we will climb the St. Augustine Lighthouse that night. Future meetings are being planned for Hillsboro and Jupiter. On the registration form for meetings you can make a tax deductible donation to the Gene Oakes Memorial License Plate Fund. You will also receive a statement at the end of the year for any profits made on the meetings you attend during the year. This statement can be claimed as a charitable tax deduction on your income tax.

Committee Reports:

Website: Stan announced that reports including the status of the website are available via email and on

the website. And Stan Beckstrom would be available to answer any questions.

Education: Although Hib Casselberry, the Education Chairman, was not present, his report in writing was handed out and the information on the Florida History Fair is on the website.

Photography: David Hanko was not present; Stan reported that there had been a discussion on having a breakout group meeting for photography.

Newsletter: Rick Mau was not present; Stan reported that Rick did the February FLASH; and continues to serve.

Archive: Stan announced Gordon Levi as Archivist. Gordon reported that UWF may be willing to take on and one day have available on-line, the history of the FLA. General information on lighthouse will not be included but specifically the history and future of FLA. Gordon has also contacted the State of Florida as a depository for the FLA archives. They will store it and put out a catalog showing what material is available, but it would not be on-line.

Publicity: Ken Smith suggested members keep copies of the new FLA brochures in their car, so they will have them to hand out to people that are interested.

Presidents Report: President Stan Farnham briefly described the Strategic Plan Session at Ponce on June 17th for officers and board members. The session will include strengths, weakness, threats, opportunities, critical issues, goals and an action plan agenda with a sharply focused set of goals. Every member has an opportunity thru the Survey Form to contribute to the Strategic Plan.

Level A (Major) Lighthouse Reports:

Non-vital lighthouse and committee reports will be issued in writing and will not be read at the meetings. Only Level A (critically vital) reports will be given verbally at the meetings. All reports will be included in the in The Flash, and available on line. The reports are in "The Florida Lighthouse Reports" section of FLASH. Verbal reports included Jim Kemp, Cape St. George; Paul Wenglowsky, St. Augustine; Gordon Levi, Pensacola; John Kennedy, Sanibel; David D'Amicol, Cedar Key. Written reports were submitted by George Diller, Cape Canaveral; Hib Casselberry, Hillsboro; Charley Knox, Mayport.

Adjournment: President Stan Farnham turned the meeting over to Rip Puls to begin the auction at 11:10 a.m.

FLA at the FAIR

Florida Lighthouse Association Booth at the Central Florida Fair, April 20-30, 2006

Dedicated volunteers Eric Martin and Judie Trotter promoted the Florida Lighthouse Association and Florida lighthouses with initiative and flair after arranging and setting up a booth at the 94th Annual Central Florida Fair.

Martin wheedled the fair managers for an attractive glass case that fronted the booth and displayed his lighthouse replica collectibles.

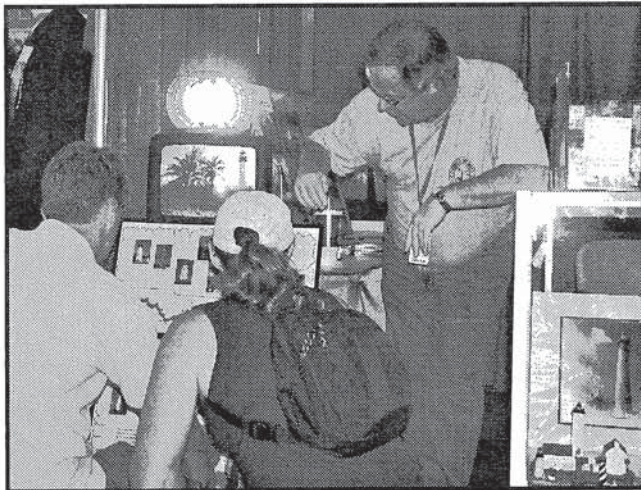
A small replica Fresnel lens by Emmons, flashed and attracted visitors to the booth. "What is that?" One visitor asked. Martin explained the lighthouse lens.

A DVD on all Florida lighthouse cycled on a small television set. Judie Trotter had the DVD done by donating her own money (\$300) to produce it. She has used it in talks at schools and libraries. The DVD grabbed visitor's attention once they were at the booth. This can be used by the Florida Lighthouse speaker's bureau to augment presentations to groups and potential donors.



A large map of the thirty remaining Florida lighthouses caused visitors to ask about visiting the lighthouses.

One young couple asked: "We would like to visit all thirty lighthouses. How long would that take?" Martin suggested they do it in steps and read Tom Taylor's book first for detailed directions to each.



"Some are not accessible," Martin said. "Others are not open or are on military bases. A good reason to join the association is that you can visit lighthouses not open to the public because we hold quarterly meetings at them."

In just a short while on Sunday afternoon April 23, five couples stopped in to ask questions. To each Martin provided the information based on the experience of a person who has visited all thirty lighthouses and a veteran of previous fairs. He gave each one of the new pamphlets and urged them to join. Three of the couples said they definitely would do so. With eleven days and 93 hours of operations and hundreds of visitors to the booth, the large potential for new members and visitors to Florida lighthouses makes the effort worthwhile.

"The new pamphlet really helps. Last year all we had was a cheap looking Xerox copy of a membership form to hand people. Now we have a professional pamphlet that helps us look like the professional organization we are," Martin exclaimed.

By meeting the mandatory hours of staffing the booth, the fair managers will pay \$200 to the Florida Lighthouse Association. Martin also sold raffle tickets to a print of a lighthouse painting for further fund raising of \$214.37.

Martin's daughter, Brooke, helped him out on this weekend. Martin, a history major, graduated from University of Central Florida, 1981. He has a full-time job but still manages to put in long hours for FLA at the booth.



Judie Trotter also staffs the booth on several days as she has for several years. For the weekend of this story, she attended the FLA meeting in Tierra Verde. Other FLA members helped out along with Judie Trotter: Dave D'Amicol, Dorothy and Ed Butler and Bill Wilkins. Martin also drafted his family for booth service: Wife Susan and children Steven (21), Ian (14) and Brooke (10).

Martin talks about Florida lighthouses to "customers" and future FLA members: "I enjoy talking about lighthouses and it is only a chore when it is slow."

A Modern Day "Sleeping Beauty"

The current iron skeleton tower that stands on Cape San Blas in the Florida panhandle replaced 3 previous conical towers destroyed by storms, hurricanes, and eroding shoreline. This tower, built in 1885, was moved to its present location about a quarter of a mile from the shore in 1918. Unlike most iron towers, the central column, which houses the spiral staircase, does not extend from the lantern room to the ground. Instead, it stops twenty feet from the ground. An external metal stairway accesses the door to the tower. The tower stands 98 feet high and has 138 steps to the top. The uniqueness of this lighthouse however is its original third order bi-valve clamshell lens, which still remains in the tower. But – the big story at Cape San Blas these days is not the lighthouse, but rather the two keepers' quarters. The buildings were left neglected and unattended for many years and began to suffer massive deterioration. In 1996, the lighthouse was deactivated. Two years later, the keeper's house closest to the shore received considerable damage from Hurricane Earl. Finally, in 1999 both dwellings were moved from their position on the shore to a site next to the tower. The building in the best condition was restored with completion in 2002. Needless to say, the second dwelling continued to deteriorate and looked more like a candidate for a wrecking ball than a restoration. It was pitifully dilapidated and leaning badly to one side. In 2004, structural stabilization and extensive renovations began. By 2005, the job was completed and "Sleeping Beauty" emerged!

Eglin Air Force Base controls access to the lighthouse compound. Our request for permission to climb was referred to the Department of Environmental Management at Eglin. Initially our request was denied but upon further consideration, they have given us **permission to climb the tower**. We will also have full access to both keeper's quarters and the grounds around the tower, which will afford outstanding photo opportunities.

Our meeting will be in the Fellowship Hall at St. James Episcopal Church, located at 800 22nd St. in Port St. Joe. (This is the corner of 22nd St. and

Garrison Ave.) The luncheon will also be held in the hall and will be catered by *Half Shells Restaurant* from Mexico Beach. They have received accolades by several national food publications for their peel-n-eat shrimp. *Of course, this will be our featured item on the menu.* We will also provide a pasta salad for those unable to eat shrimp.

We are most privileged to have as our speakers for this meeting Bob and Sandra Shanklin – otherwise known as "The Lighthouse People". On their wedding trip in 1987 they traveled to New England and began photographing lighthouses. Portland Head Light was their first and it was love at first site. Since then, they have traveled all over the US in search of lighthouses. They have counted about 670 lights – both major and minor – and have photographed every standing lighthouse including Alaska, Hawaii, and Puerto Rico. They have published multiple books which can be purchased on their website at www.thelighthousepeople.com. Their photographs are also available for purchase. Their presentation will include stories of their adventures and a question and answer session. They will also have merchandise available for purchase and will personally autograph the books.

Also located near the Cape San Blas Lighthouse is the St. Joseph Point Light. The present tower, built in 1902, is a square wooden tower on the roof of a one-story keeper's dwelling. Originally located at Beacon Hill, it was moved to St. Joseph Bay on the Gulf of Mexico. The light was discontinued in 1955, moved, and used as a barn for a time. Danny Raffield purchased the light in 1970 and moved it again to its present location at Simmons Bayou on the edge of St. Joseph's Bay. Danny and his wife have been living-in and restoring the keeper's quarters since that time. Danny plans to have a replica lantern room in place later this summer and is exploring options to find a 3rd order lens for the tower. For those wanting a lighthouse experience that few people have, Danny will take four of our meeting participants on a personally escorted tour of the house immediately following the visit to the Cape San Blas Lighthouse and keeper's Quarters. We will conduct a special raffle during our meeting

and draw the names of the lucky people who will tour the house. The proceeds of the raffle will go to the Gene Oakes Memorial Fund. (License plate project)

The Fellowship Hall has a limited capacity, so our meeting and events will be limited to 100

participants. The cost for this meeting, luncheon, and donation will be \$30. We have reserved the entire Port Inn in Port St. Joe for the night of July 14. However, there are only 20 rooms available, so reserve early if you plan to stay. The reservation deadline is June 5, 2006.

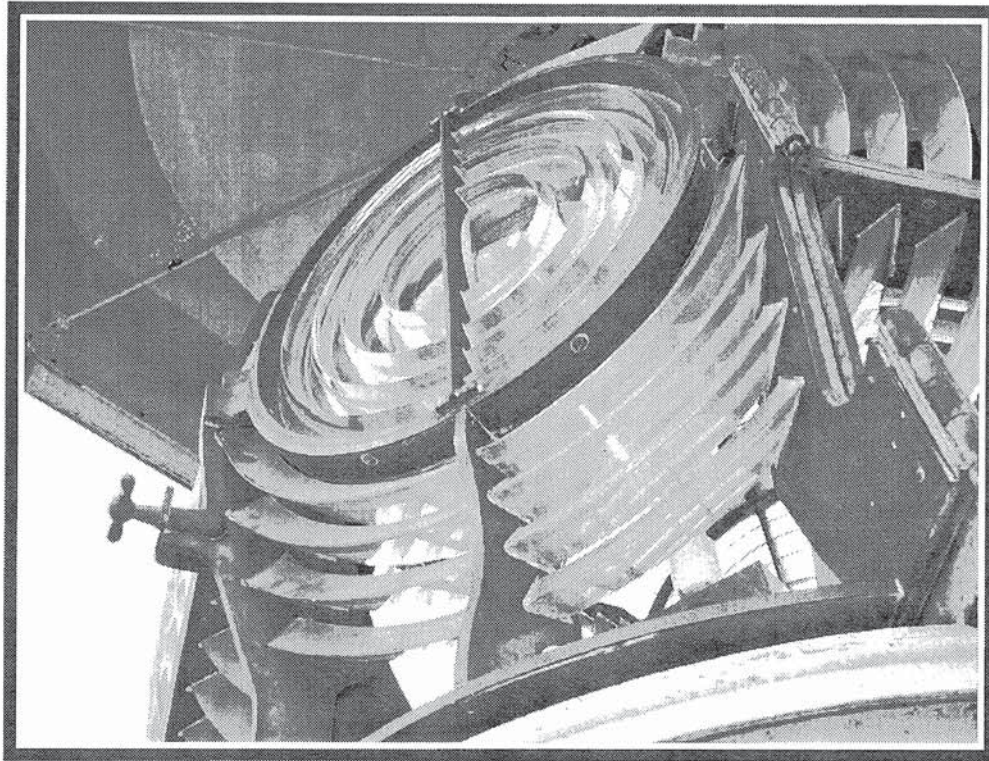
Pensacola Lighthouse Report Gordon Levi
